

## Reduced Rate Program

The Program will provide reimbursement of North Texas (Dallas) chapter membership dues to individuals who satisfy a qualifying classification **AND** who remain active with the North Texas (Dallas) chapter of ACP.

### Eligibility Process and Dues Reimbursement

<b>For New Members:</b>	<ol style="list-style-type: none"> <li>1. Join the North Texas (Dallas) chapter on the ACP International Internet Site (<a href="http://www.acp-international.com">http://www.acp-international.com</a>)</li> <li>2. Match one (1) of the classifications from the eligibility qualifications</li> <li>3. Email the Membership Director to request participation in the Reduced Rate Program (<a href="mailto:northtexas@acp-international.com">northtexas@acp-international.com</a>) – include your eligibility classification, a copy of the paid invoice, and a physical mailing address</li> <li>4. Membership Director will verify your eligibility and if qualified a dues reimbursement check will be sent to the mailing address you provided</li> </ol>
<b>For Renewing Members:</b>	<ol style="list-style-type: none"> <li>1. Renew membership to the North Texas (Dallas) chapter on the ACP International Internet Site (<a href="http://www.acp-international.com">http://www.acp-international.com</a>)</li> <li>2. Match one (1) of the classifications <b>AND</b> one (1) of the activities from the eligibility qualifications</li> <li>3. Email the Membership Director to request participation in the Reduced Rate Program (<a href="mailto:northtexas@acp-international.com">northtexas@acp-international.com</a>) – include your eligibility classification, a copy of the paid invoice, and a physical mailing address</li> <li>4. Membership Director will verify your eligibility and if qualified a dues reimbursement check will be sent to the mailing address you provided</li> </ol>

### Eligible Reimbursement

<b>Period:</b>	<ul style="list-style-type: none"> <li>• Once per year, per member, <u>at the time</u> of Joining (New) or Renewing membership</li> <li>• Reimbursement requests must be submitted by November 30th of the same year the North Texas (Dallas) chapter membership dues are paid</li> </ul>
<b>Rate:</b>	<ul style="list-style-type: none"> <li>• 100% of <u>paid</u> North Texas (Dallas) chapter membership dues for the current year of the reimbursement request</li> <li>• National dues are <u>not</u> eligible for reimbursement from the Reduced Rate Program</li> </ul>

### Eligibility Qualifications

<b>Classifications:</b>	<ul style="list-style-type: none"> <li>• Unemployed (seeking employment)</li> <li>• Full Time Student (as defined by your institution)</li> <li>• Retired (non-consultant)</li> </ul>
<b>Activities:</b>	<ul style="list-style-type: none"> <li>• Attended at least one (1) Membership Event of the North Texas (Dallas) chapter <u>per quarter</u> in the prior calendar year for a total of 4 events</li> <li>• Attended at least six (6) Membership Events of the North Texas (Dallas) chapter in the prior calendar year regardless of quarter for a total of 6 or more events</li> </ul>

The Reduced Rate Program may be revoked, modified, or suspended at any time and without notice by the current North Texas (Dallas) chapter Board of Directors.
